#### CONVENTIONAL WARRANTY

This Conventional Warranty ('the "Warranty") issued by Cicli Pinarello S.r.l. ("Pinarello") applies to all original Pinarello frames purchased by ("Customers") from an authorized retailer and registered on the website www.pinarello.com ("Products"), according to the following terms and conditions as of July 2, 2018, as well as to Products previously registered to which Pinarello will extend this warranty.

#### REMISE

#### 1.1 Useful Lifecycle of Products and Designated Use

Pinarello advises that all the bicycle components (frame, wheels, cranks, handlebars, shifters, tyres, etc.) have a useful lifecycle that varies according to the bicycle model and depends on a range of factors. Factors may include, for example, the material and technologies of the individual Product, the weight and power of the cyclist, the care and maintenance of the product, the frequency and handling of the Product, the use of aggressive cleaning agents, and external factors such as impacts, knocks, or falls.

The Product and its parts are subject to normal superficial wear from regular use but are also subject to material fatigue. This is a progressive separation of the molecular structure that initially appears as a barely noticeable micro-fracture that gradually gets bigger until the Product or the single component is weakened to the extent that it may collapse once the fracture has increased beyond its limit. Material fatigue is dangerous as it is barely visible. To reduce the risk of accidents, it is necessary to mitigate the conditions that lead to normal wear and material fatigue of the Product and its components by ensuring that the Product is properly maintained with a frequency in keeping with factors such as frequency of use, type of use, and the weight and power of the cyclist.

To maximise safety, it is therefore essential to ensure that the Product, and its components, are regularly inspected by a qualified mechanic who can detect wear, cracks, micro-fractures, corrosion, deformations, dents, paint damage, and any other indicator of flaws that may compromise the safety of the Product before its structural integrity is weakened. Given these safety risk indicators' poorly visible nature and detectability, using micro-fracture detectors such as penetrating liquids is recommended.

Any worn Product or component that has lost its structural integrity or shows damage or signs of fatigue must be replaced immediately and should not be used until it is replaced to reduce the risk of accidents.

The Products have been designed for specific uses based on their features. For example, the racing models are intended solely for track or smooth road use, while the MTBs are built for outdoor use on unpaved and downhill roads. Each Product must, therefore, be used in accordance with its features and structure ("Designated Use").

Risks are inherent in using the Product, and risk factors are heightened by poor bicycle maintenance, lack of frequent inspections, poor visibility, darkness, or weather conditions that could compromise the Product and the user's safety by increasing the accident risks. In all cases, we recommend proper maintenance of the Product and its components, frequent inspections, the use of a helmet and high-visibility clothing, lights, rear-view mirrors, acoustic warning devices, and careful cycling. While these precautions will not eliminate risks, they may help to reduce them.

#### 2. WARRANTY TERMS

#### 2.1 Subject matter and duration of the Warranty

Pinarello guarantees the Products against production and material defects under the terms and conditions set out below. This Warranty applies solely to original Pinarello Products purchased by a Customer from authorised Pinarello retailers and registered through the website www.pinarello.com within thirty (30) days from the date of purchase indicated in the Product's proof of purchase document ("Purchase Date").

This Warranty is valid for five (5) years from the Purchase Date. The first two (2) years are covered by the legal warranty. Legislative Decree 128 and following. 205/2006 ("Legal Warranty"). From the third to the fifth year, the Warranty is valid if the Product has been registered on the website www.pinarello.com within the period indicated above.

The Warranty also grants the Customer access to the "Crash Replacement" program.

This Warranty and the "Crash Replacement" program only applies to Pinarello Products in the catalogue at the time of their registration on the website www.pinarello.com and/or in the previous 24 months

#### 2.2 Content and exclusions of this Warranty

The Warranty applies exclusively to the Products, as defined above, and excludes all components, and in particular, parts or components produced by third parties that are included on Pinarello bicycles. Such components are covered by their own manufacturers' warranties, where provided.

If Pinarello acknowledges the existence of a defect in the Product validly claimed in accordance with this document within the term of the Warranty, it will be limited, at Pinarello's discretion, to the following alternative remedies:

i) Repair without charge of the Product or parts of the Product found to be defective or

ii) Replacement without charge of the Product or parts of the Product found to be defective.

If the Product or component recognised as defective is unavailable, it will be replaced with a similar Product or component of the same approximate value. It is understood that, in the event of replacement of a Product or component, this Warranty does not cover the labour costs required for replacement.

- In this Warranty, the following are explicitly excluded:
- i) Non-original Pinarello Products or products not purchased from an authorised Pinarello retailer.
- ii) Products whose identification codes have been removed, altered, deleted, or made illegible.
- iii) Products that have been even partially repainted.
- iv) Products used as samples and/or for display purposes.
- v) Products that have been modified by the user or by third parties. vi) Products that have not been purchased by the Customer and/or the user but made available to them e.g., through rental contracts,
- loan agreements, etc., concluded with the authorised retailer.
  vii) Products used and subsequently resold by the authorised retailer

viii) Defects arising from normal use (including so-called material fatigue).

- ix) Defects caused by abuse or misuse of the Product or its com-
- x) Defects resulting from incorrect assembly according to Pinarello's assembly conditions (for example, incorrect tightening torques).
- xi) Defects resulting from incorrect or insufficient maintenance, such as but not limited to defects resulting from material corrosion, use of aggressive cleaning agents or incompatible Products, or from repairs carried out by non-authorised retailers.
  xii) Defects arising from accidents or other events not caused by
- defects covered by this Warranty.
  xiii) Products that have reached the natural end of their useful life-
- xiv) Defects caused by exposure to UV rays (discolouring, yellowing).
- xv) Defects caused by corrosion from a saline environment.
- xvi) Damage caused by the careless transport of the Product (the carrier is deemed responsible).
- xvii) Aesthetic defects that were easily detectable at the time of purchase of the Product.
- xviii) Defects resulting from use that does not conform to the Designated Use.

This Warranty is not transferrable and applies solely to the original Customer as a result of registration on the website www.pinarello. com.

This Warranty, intended as an addition to the warranties afforded by mandatory legal regulations and potential Warranty rights provided by the applicable law of the national legislation of the State in which the purchase was made, will remain uncompromised. The unlawfulness, invalidity, or ineffectiveness in all or in part of any of the provisions stipulated by this Warranty in accordance with applicable national laws will not compromise the validity, lawfulness, and effectiveness of the remaining provisions of this Warranty.

This document constitutes the only conventional warranty issued by Pinarello on its Products and explicitly excludes any supplementary clause, extension, or implicit warranty regardless of who issues it.

In the event of replacement and/or repair under the warranty of a Product or component thereof during the first two (2) years covered by the Legal Warranty:

- i) The replacement Product or component benefits from a new warranty under the terms and conditions set forth in this document.
- ii) Spare parts that, during a repair, are incorporated into the Product, do not enjoy a new warranty, but with respect to them, the term relating to the first delivery of the Product continues to run without prejudice to the possibility of reiteration of the repair/replacement remedies under the terms and conditions provided herein.
- iii) The replaced product, or part thereof, becomes the property of Pinarello.

In the event, however, of replacement and/or repair under warranty of a Product or part thereof during the following three-year period covered by this Warranty, the Product or parts of the Product replaced and/or repaired will not enjoy a new warranty period, with-

out prejudice in any case to the possibility of repetition of the repair/replacement remedies until the end of the three-year period.

### 2.3 Claim Procedure

Below, Pinarello indicates the procedure that must be followed under penalty of forfeiture to correctly submit a claim for a defect. The correct execution of the following procedure will allow you to benefit from the Warranty where the defect is recognised by Pinarello according to this document. To claim for a defective Product or component, the Customer must go to the same authorised Pinarello retailer where he made the purchase within the term of forfeiture of 8 (eight) days from the moment in which the defect occurred or from which he became aware of it, delivering the Product considered defective, in a good state of cleanliness, along with: i) A copy of the proof of purchase document of the Product indicating the date of purchase.

- ii) A detailed description of the defect (Pinarello suggests using adhesive tape to pinpoint the exact position of the defect).
- iii) A photograph in .jpeg format of the Product.
- iv) Photographs in .jpeg format that clearly highlight the problem or defect.
- v) Photograph of the bottom bracket with a clearly visible serial number.
- number.
  vi) A description of the assembly (set-up) carried out on the Product in question.
- vii) A copy of the email confirming the registration of the serial number of the Product on the website www.pinarello.com.
- viii) An indication of whether the customer wants the Product returned if the Warranty is not deemed applicable.

To verify that the claim procedure detailed in this paragraph is correctly carried out, the delivery date of the Product to the authorised retailer will be considered. Please note that the Product deemed defective must still be delivered to the authorised retailer from which the Product was originally purchased, even if it is in a different country than the Customer's country of residence or the country in which the Product is used. For this reason, Pinarello recommends, both for better safety regarding the assembly and pre-delivery checks of the Product and for a better after-sales service, that the customer buys the Product from an authorised Pinarello retailer near the Customer's residence. The existence or non-existence of the defect will be verified by Pinarello, and therefore, the operation of the Warranty according to the purposes of this document is subject to prior inspection and authorisation by Pinarello, If, following a correctly submitted claim according to this document. Pinarello acknowledges the existence of the defect, the Product will be replaced or repaired at the discretion of Pinarello

## 2.4 Liability Exemption

according to paragraph 2.2 above.

Pinarello is not liable for damages, its liability being limited to the practice of the remedies explicitly indicated in this Warranty, unless otherwise provided for by any applicable law. Indirect, consequential, or accidental damages, are excluded. The Product Customer declares to be aware that the Product, subject to the warranty procedure (legal and/or conventional), could be subject to faults or defects that affect its use and/or safety and, therefore, having requested to be able to use this Warranty, declares to:

 i) Commit to not using the Product for which you have reported the existence of faults or defects.

- ii) Assume any civil or criminal liability for any damage to persons and property that may arise from the use of the Product.
- iii) Exonerate and indemnify Pinarello from all civil and criminal liability, for any damage to persons and/or property that may arise from the use of the Product and, as a result, renounce from now on to make any claim, including compensation, against Pinarello.

Pinarello undertakes to promptly notify the Customer of the waiting times for the completion of the Product replacement and/or repair procedure. It is understood that Pinarello does not assume any obligation to replace and/or repair the Product or component within a predetermined time and that the waiting times communicated constitute a non-binding estimate and may be subject to subsequent changes.

## 3. CRASH REPLACEMENT PROGRAM

#### 3.1 Enrolment in the program

The correct registration of the Product on the website www.pinarello.com within 30 (thirty) days of the purchase of the Product also entails enrolment of the Customer in the "Crash Replacement" program.

Only the Pinarello Products in the catalogue at the time of registration or in the previous 24 months are eligible.

The enrolment in the "Crash Replacement" program gives the Customer the right to benefit, once only, from the following advantages in the event of irreparable damage to the Product that does not qualify for free-of-charge replacement due to non-compliance with the Warranty terms above.

The "Crash Replacement" program cannot, therefore, be activated on the Product purchased by the Customer benefiting from the "Crash Replacement" program, nor on Products that have not been in the Pinarello catalogue for more than 24 months prior to the registration date.

The enrolment in the "Crash Replacement" program implies the Customer's right, in the event of damage to the Product, to purchase from the same authorised retailer from which the purchase was made a replacement Product of the damaged one, of the same or lower category, at a discounted price.

Quantification of the discount will be made available each time by the Authorised Retailer as a portion thereof is offered by Pinarello while the remaining portion is offered by the Authorised Retailer at their discretion. To find out the quantification of the discount, you will need to contact an authorised retailer.

- The Customer will be entitled to the application of the aforementioned discount under the following conditions:
- The Product, as specified above, is registered at the website address: www.pinarello.com within 30 (thirty) days from the date of purchase.
- ii) The event that caused the damage occurred within the effective terms of the Warranty (within five years from the date of registration).
- iii) The damaged Product must be returned to Pinarello.
- iv) The purchased Product is used for the purpose of replacing the damaged Product.
- v) The Product purchased for the purpose of replacement has a

value equal to or less than the damaged Product.

vi) The Product must be a PINARELLO frame. A proof of purchase will be requested to take advantage of the discount reserved for Customers enrolled in the "Crash Replacement" program.

# 3.2 Procedure for applying the discount provided for Customers enrolled in the Crash Replacement program.

In order to take advantage of the discount reserved for Customers enrolled in the "Crash Replacement" program, the Customer must notify the authorised retailer from which the original purchase was made, in writing, of the damage to the Product, indicating their intention to purchase a replacement Product and take advantage of the discount provided in the "Crash Replacement" program. In the aforementioned communication, the Customer must indicate:

- i) The serial number of the Product.
- ii) The proof of purchase document in which the date of purchase is indicated in a clear and legible manner.

  iii) A copy of the email confirming the registration of the serial num-
- ber of the Product on the website www.pinarello.com. iv) A photograph in .jpg format of the Product and the damaged
- v) Photograph of the bottom bracket with a clearly visible serial number.
- vi) A short, written description of the incident that caused the damage.

vii) Any report of the claim to the authorities.

The application of the discount by the authorised retailer will be subject to prior authorisation by Pinarello for the purpose of verifying the existence of the conditions of applicability of the benefits referred to in the "Crash Replacement" program. Following the replacement of the Product according to this paragraph, the replaced damaged Product shall become the property of Pinarello.

#### 4. APPLICABLE LAW AND EXCLUSIVE JURISDICTION

This Warranty is subject to Italian law Any dispute arising from or connected to the validity, interpretation, and execution of this Warranty will be submitted to the exclusive jurisdiction of the Court of Treviso without prejudice to the mandatory jurisdiction established by the Consumer Code, where applicable, or by other mandatory rules that may be applicable.

#### 5. POWER OF AMENDMENT

Pinarello reserves the right to cancel or modify the terms of this Warranty at any time through a publication on its site. The changes will become automatically applicable from the date of publication on the site without compromising the rights already accrued by the Products' Customers from the date of publication of the changes on its website.

#### INTRODUCTION

#### Dear Pinarello Customer.

In this manual. Pinarello provides recommendations for your bicycle use with care and maintenance instructions. It is essential to read this manual, even if you consider yourself an expert cyclist, as bicycle technology is rapidly changing.

For safety and to guarantee the durability of your new bicycle, we recommend reading this manual, paying particular attention to the instructions on assembling and setting up your bicycle for its first ride and the general instructions on the correct use of your bicycle.

It should also be noted that the explanations and instructions given here may not account for all situations as specific factors such as experience, manual skill, and the tools used by anyone working on the bicycle will vary. This is not a bicycle assembly manual and cannot completely replace the experience and knowledge of an expert mechanic. For these reasons, if you have any support needs, Pinarello always recommends that you refer to the network of official Pinarello dealers for their irreplaceable professionalism and expertise.

To conclude, Pinarello wishes to emphasise that the bicycle is a means of transport and, like all other road and off-road bicycles, involves significant risks of injury and damage to users. It is important to acknowledge and accept the risks and take all the necessary measures to minimise them.

Always ride your bicycle with the utmost caution, respecting other road users. Never ride the bicycle after taking medication, alcohol. or drugs, or if you are tired. Never carry another person onboard your bicycle. Always keep both hands on the handlebars. Always follow the local road rules. When cycling off-road, always respect nature by following marked trails and routes. Wear appropriate clothing for cycling, including a helmet, eye protection and suitable high-visibility clothing.

#### WARRANTY

The Pinarello bicycle is covered by a legal warranty valid for two years from the date and time of purchase, with a possible extension of a further three years subject to registration of the frame serial number within 30 days of purchase at this address: https://pinarello. com/europe/en/frame-registration

#### GENERAL RECOMMENDATIONS AND WARNINGS



The information and instructions in this manual are not intended as a guide for repairing or assembling a bicycle from individual parts.



Respect the rules of the road. Keep your hands on the handlebars at all times. Do not engage in behaviours that could cause danger to yourself and other road users. Never take a tow from another vehicle. Never take your feet off the pedals unless the road conditions or a situation requires you to do so



Do not attempt to do any maintenance, repair, adjustment, or assembly work on the bicycle unless you are experienced and know exactly what you are doing. Mistakes can pose high risks to your safety. If in doubt, contact an authorised Pinarello dealer for support.



Always read the specific user manual provided by the manufacturers of the different components.




Never mount luggage or large, heavy objects on the handlebar, as this increases the risk of falling.



Avoid wearing skirts or other long and loose clothing while riding the bicycle. Do not attach ropes, cords, or similar objects to your bicycle. They could get caught in the wheels or drivetrain



#### FIRST RIDE WITH YOUR PINARELLO

- 1. Before riding your Pinarello bicycle for the first time, it is a good idea to fine-tune the bicycle set-up with the help of a trusted Pinarello dealer to ensure that the bicycle meets your specifications and that all components operate in the right working ranges. It is also worth familiarising yourself with your bicycle by practising in a safe place away from risks to yourself and other road users.
- 2. The Pinarello bicycle is designed to support a maximum weight of 120 kg (264.5 lbs), including rider, bicycle, luggage, and accessories. Make sure you do not exceed this limit. When buying the bike, remember that it is always good to check the weight limit of the cyclist and also the weight limits of third-party components, as the maximum weights declared may differ from the limit indicated above. Always refer to the corresponding manual for detailed
- 3. Check, with the advice of your trusted Pinarello dealer, that the bicycle is equipped with all the devices required by the road traffic laws where you intend to use it.
- 4. Check and familiarise yourself with the braking system. The brakes may be more responsive and effective than the ones you are used to, so test them first. Also, check that the levers operate the brakes in the combination you are used to using.
- 5. Familiarise yourself with the shifter system and how it works, especially if it is different from the systems you have used previously. 6. If you have equipped your bike with quick-release or clipless pedals, ask the Pinarello dealer to help you set up and become familiar with them.



Incorrect closing of guick-release skewers, fasteners, or thru axles may cause parts of the bicycle to detach and may result in a fall hazard.

- 3. Make sure the tyres are in good condition and inflated to the correct pressure. The recommended pressure (which may vary depending on the route and weather conditions) is usually indicated on the tyre sidewall. Spin the wheels idle to check that they are centred and have no damaged or broken components (skewers, spokes etc...)
- pletely with the bicycle stopped, checking that the pressure point is reached without the lever touching the handlebar. On hydraulic brakes, check for leaks.
- 5. Check that the bicycle is equipped with the devices required by the road laws in force in the country where you are cycling. Riding without lights or reflectors in conditions of poor visibility or darkness is extremely dangerous.
- Carefully inspect bicycle components for signs of wear or fatigue, such as cracks, scratches, dents, bulges, or discolouring. The use of the bicycle, especially on rough roads, subjects it to stresses and



If you detect signs of wear or damage on any of the bicycle components, contact your trusted Pinarello dealer to have the component replaced. If you detect damaged components or any component that shows signs of wear, do not use the bicycle, as sudden failure of a component without warning can pose high safety risks.

We recommend that before every ride with your Pinarello bicycle. you carry out a series of checks to ensure that your bicycle is in good working order and for your own safety. Even during transport or after a long period of downtime, there could be minor changes to the bicycle's settings and performance.

- 1. Check the front and rear wheel thru axles to make sure they are well secured to the fork and frame.
- 2. Check the front and rear wheel thru axles or quick releases to make sure they are secured and fastened at the recommended toraue.

The frame of your Pinarello does not require any type of preparation. Do not drill, modify or remove any parts of your frame. Failure to follow this instruction could result in sudden breakage and personal injuries and will void the warranty.

## **TYRE PRESSURE**

Check that the tyres are inflated to an adequate pressure. We recommend that you adapt the pressure to your cycling skills and preferences. There is no precise way to identify the suitable tyre pressure for each individual user. The user and the terrain are both determining factors for optimum tyre pressure. We suggest that you get advice from your trusted Pinarello dealer on the correct tyre pressure especially when using your bicycle for the first time.

#### SEATPOST

DO NOT cut or alter the seatpost in any way. Make sure that it does not protrude beyond the "minimum insertion point" marked with a dashed line. If using a carbon seatpost, apply the mounting paste on the seatpost and inside the seat tube. For this procedure, only use mounting paste for carbon parts.

#### **TIGHTENING TOROUES**

The maximum permitted tightening torques are indicated on the components themselves. Always tighten to the recommended torque. If the torque indications are missing or illegible due to wear, consult your trusted Pinarello dealer.

#### **GENERAL MAINTENANCE AND CARE**

The Pinarello bicycle is a high-quality product. It requires continuous, quality care and regular maintenance by a specialist to keep it in perfect working order over the long term.

## GENERAL CLEANING AND MAINTENANCE

Sweat, dirt, salt from winter roads, sea salt, mineral salts, and maltodextrin will damage your bike, meaning that your bicycle and its components require regular cleaning to protect them from corroNever clean your bicycle with a pressure washer. The high jet pressure forces water into the seals and bearings, diluting the lubricants and increasing the friction on moving parts, leading to rapid wear and corrosion.

It is best to clean your bike with a gentle spray of water and a sponge or brush. This also lets you inspect the bicycle closely for early detection of signs of wear or damage. We recommend that you contact your Pinarello dealer for the purchase of specific products suitable for the cleaning, care, and lubrication of your bicycle. After cleaning, rinse the entire bike with a light spray of water and leave it to dry.

After cleaning, check the chain and, if necessary, lubricate it with the appropriate products recommended by your authorised dealer. When cleaning, pay attention to any cracks, scratches,



discolourations, bulges or deformations of material in the components. If in doubt, have your bike checked by your trusted Pinarello dealer, who can provide assistance and, if necessary, replace damaged components.



Only use products specific to bicycle care. Aggressive, non-neutral degreasers or chemical detergents could cause cosmetic, surface damage or, worse, alter the features of important components such as moving parts

Do not apply cleaning and care products or chain



Make sure you have rinsed the bike thoroughly to remove any chemicals that could cause cosmetic or structural



lubricant, to the brake pads or discs. This could reduce the braking performance and pose serious safety risks.

#### INSPECTION AND MAINTENANCE

We recommend that you have the bicycle checked periodically by your trusted Pinarello dealer. An assembly check should be carried out after the first few kilometres travelled for purposes of adjustment once the components have settled in. After that, we recommend that the bike be inspected periodically (annually).

It is advisable to use only original spare parts or alternative

These inspections make it possible to detect any worn components and to then restore the bicycle to perfect working order



components suggested by your Pinarello dealer. Replacement components from other suppliers, and of other sizes, especially those subject to wear, may put the safety of your bicycle at risk.



The use of non-original spare parts or spare parts not recommended by Pinarello, and any repair maintenance and service carried out by unauthorised personnel will void the warranty and CE marking of the bicycle.

#### **BICYCLE TRANSPORT**

The Pinarello bicycle can be transported like any other bicycle on the appropriate car bicycle carriers or inside the vehicle. Whatever the mode of transport, check that the bicycle is correctly fixed and secured. Avoid exerting pressure or weight on the carbon parts. Periodically check the safety of the fastening during transport. Transporting the bicycle on public transport is generally allowed.

However, check the transport system rules and regulations for information on permissible time slots and additional costs. Air transport requires specific packaging. In the case of air travel, it is essential to contact the airline or the courier in advance of trav-

NOTE: In the case of electric bicycles, it is recommended that you check the legal regulations that apply to transporting bikes by pub-

lic transport such as ferries and aeroplanes etc. in your location.



Before transporting the bike on the outside of a vehicle, make sure that all the moving parts and separable components have been removed or properly fixed in place.

Check whether the road laws where you are travelling



require special signs or other measures for transporting picycles on vehicle-mounted bicycle carriers.



Pay attention to the weight of the bicycle when handling and loading/unloading, and when placing more than one bicycle on the roof of the car or on external bicycle carriers. Check the weight limits indicated by the manufacturers of the bike carrier and the vehicle.

When transporting the bicycle inside a vehicle, never



leave the bicycle in a vehicle exposed to sunshine for lengthy periods. The interior temperature could cause cosmetic damage to components or alter or damage their structural or mechanical features.

#### AFTER A FALL

In the event of a fall, we recommend the following checks before riding the bicycle again.

- 1. Check that the wheels are still secure and that the rims are still centred in the frame and fork. 2. Check that the handlebar and attachment are not broken or de-
- formed by removing the handlebar tape and shifters. Check that the handlebar is still properly connected to the fork by trying to rotate the handlebar and checking that the wheel turns consistently. Apply the brakes and push the bike forward slightly to check the brake performance and ensure that the braking system is still securely fixed to the bicycle.
- 3. Make sure the chain is correctly positioned on the chainring and cassette. Check the operation of the rear derailleur by keeping the rear wheel raised; in particular, check that the derailleur does not get too close to the spokes when moving the chain on the larger sprockets. If the rear derailleur gets too close to the spokes, there


is a risk that it will end up between the spokes and cause a fall, with consequent danger to the safety of the user and to the integrity of the bicycle.


- 4. Check the position of the saddle.
- 5. Check that no deformed parts, cracks or discolourations are visible. This procedure can be completed by gently stroking all surfaces of the frame to ascertain the total absence of cracks.

Once you have completed these checks, it is possible to proceed with the utmost caution paying attention to any abnormal behaviours or noise and without forcing the pedals or brakes. In the event of abnormal behaviours, do not use the bicycle. Take it to your trusted Pinarello dealer as soon as possible for a complete and accurate inspection.

Pinarello bicycles are designed, engineered and built for a specific purpose. Any use other than the intended use may cause the bicycle sudden stress and breakage, not covered by the warranty.


